I. STATEMENT

1. On February 13, 2014, Aimee J. Adjai, doing business as Christopher Transportation & Home Cares Provider Services filed the above-captioned application.

2. The Commission provided public notice of the Application on February 24, 2014.

3. MKBS LLC, doing business as Metro Taxi, Taxis Fiesta, South Suburban Taxi, Northwest Suburban Taxi and Colorado Cab Company LLC, and Colorado Springs Transportation LLC (collectively, interveners) timely intervened of right. This means that the interveners object to Ms. Adjai's Application. The interveners request a hearing on the Application.

4. During the Commission's weekly meeting held April 2, 2014, the Commission deemed the Application complete and referred it to an administrative law judge (ALJ) for disposition.

5. In anticipation of the hearing on the Application, the undersigned ALJ is scheduling a prehearing conference in accordance with Rule 1409(a) of the Rules of Practice and Procedure, 4 *Code of Colorado Regulations* 723-1.

6. At the prehearing conference, the ALJ will provide information concerning the procedural aspects of this case, and will schedule a hearing on the Application and will establish deadlines for the parties to file and serve all evidence they wish to be considered in support of their position in this proceeding.

7. All parties are expected to appear at the prehearing conference.

8. Ms. Adjai is advised that she may hire an attorney at her own expense to represent her in this proceeding. However, since she is an individual, she is entitled to represent herself. Rule 1201(b)(I), 4 CCR 723-1.

9. If Ms. Adjai chooses to represent herself in this proceeding, she will be held to the same standards as an attorney.

10. The parties are advised and on notice that failure to appear at the prehearing conference may result in dismissal of the Application without prejudice, or a decision denying intervenor the ability to participate in this proceeding.

II. **ORDER**

A. **It Is Ordered That:**

1. A prehearing conference in this proceeding is scheduled as follows:
