**I. STATEMENT**

1. On April 15, 2014, the Unopposed Motion to Extend ZippyTech's Deadline to Answer or Satisfy the Complaint was filed by Staff of the Colorado Public Utilities Commission (Staff). Staff reports that the parties have reached an agreement in principle as to how ZippyTech will satisfy the Complaint, but additional time is needed to finalize the terms of agreement and to file an appropriate motion.

2. ZippyTech has not entered an appearance in this proceeding, but company representatives do not oppose the relief requested in the motion.

3. The request being unopposed, it is appropriate that response time be waived.

4. Good cause shown for the unopposed request, the motion will be granted.

**II. ORDER**

**A. It Is Ordered That:**

1. Response time to the Unopposed Motion to Extend ZippyTech's Deadline to Answer or Satisfy the Complaint filed by Staff of the Colorado Public Utilities Commission filed on April 15, 2014, is waived and the request granted.

2. The deadline for ZippyTech to satisfy the Complaint or file its answer is extended to April 25, 2014.
