I. STATEMENT

1. On April 17, 2014, Luke A. Hagedorn, Esq. submitted a Verified Motion to Appear *Pro Hac Vice* as Counsel for SunShare, LLC (Verified Motion).

2. No response has been filed to the motion.

3. Commission's Rules of Practice and Procedure, 4 *Code of Colorado Regulations* (CCR) 723-1-1201(a) governs admissions to appear before the Commission for attorneys not licensed to practice in Colorado. This rule in turn refers to Rule 221.1, Colorado Rules of Civil Procedure (Colo.R.Civ.P.).

4. Mr. Hagedorn is an attorney in good standing in the States of Missouri and Kansas. A notarized Affidavit listing Mr. Hagedorn's education and legal experience was attached to the Verified Motion.

5. On April 22, 2014, the Commission received notification from the Colorado Supreme Court that the motion and required fees have been received. The notice states that Mr. Hagedorn has been assigned a *pro hac vice* registration number in regards to this matter.

6. As an out-of-state attorney Mr Hagedorn may be permitted to appear in this matter, in the discretion of an administrative hearing officer in this state. Rule 221.1, Colo.R.Civ.P.

7. The Verified Motion contains the statements and information required by Colo.R.Civ.P. 221. The information establishes that Mr. Hagedorn has made the required filing with, and payment to, the Clerk of the Colorado Supreme Court.

8. Pursuant to the Verified Motion, the Attorney Registration Notice, Colo.R.Civ.P. 221, and Rule 4 CCR 723-1-1201(a), good cause has been shown to grant Luke A. Hagedorn *pro hac vice* status in this matter.

II. ORDER

A. It Is Ordered That:

1. The Verified Motion to Appear *Pro Hac Vice* as Counsel for SunShare, LLC filed on April 17, 2014 by Luke A. Hagedorn, Esq., is granted.

2. Luke A. Hagedorn, Esq, is admitted to practice before the Commission in this matter *pro hac vice*.
