GRANTING UNOPPOSED MOTION TO REVISE
PROCEDURAL SCHEDULE; AND ACKNOWLEDGING
WAIVER OF STATUTORY TIMEFRAME**

I. **STATEMENT**

1. On February 6, 2014, the Summit County E-911 Emergency Telephone Service Authority Board (Applicant or Summit County) filed an application to assess an emergency telephone surcharge rate of \$1.95 per service user per month pursuant to § 29-11-102(2)(b), C.R.S. The Application seeks to increase the Applicant's emergency telephone service surcharge rate by \$0.45 from \$1.50 to \$1.95 per service month.

2. On February 7, 2014, the Commission gave notice of the Application.

3. On March 7, 2014, the Colorado Office of Consumer Counsel (OCC) timely filed its Notice of Intervention of Right and Request for Hearing in this proceeding.

4. On March 7, 2014, Staff of the Commission (Staff) also timely filed its Notice of Intervention, Entry of Appearance, Notice Pursuant to Rule 1007(a) and Rule 1401, and Request for Hearing.

5. On March 12, 2014, by Minute Order, the Commission referred this matter to an Administrative Law Judge (ALJ).

6. On March 17, 2014, by Interim Decision R14-0293-I, a prehearing conference was scheduled for April 3, 2014, to address a procedural schedule.

7. On April 2, 2014, by Interim Decision R14-0352-I, a procedural schedule was adopted and an evidentiary hearing was scheduled for June 13 and 16, 2014.

8. On May 8, 2014, the Applicant filed its Unopposed Motion for Waiver of the Statutory Timeframe and to Establish a Revised Procedural Schedule (Motion). As grounds the Applicant states that more time is required in order to obtain information which will be required for the hearing. The Applicant also agrees to waive the statutory time limits for a Commission decision. The parties have agreed to the following procedural schedule:

Evidentiary Hearing	September 11 and 12, 2014
Statements of Position	October 3, 2014

9. Good cause is found to grant the Motion and adopt the proposed procedural schedule.

10. Since the Motion is unopposed, the undersigned ALJ shall *sua sponte* waive response time.

II. ORDER

A. It Is Ordered That:

1. The Unopposed Motion for Waiver of the Statutory Timeframe and to Establish a Revised Procedural Schedule (Motion), filed by the Summit County E-911 Emergency Telephone Service Authority Board on May 8, 2014, is granted.

2. The evidentiary hearing scheduled for June 13 and 16, 2014 is vacated.

3. Response time to the Motion is waived.

4. The procedural schedule agreed to by the parties and listed in ¶ 8 is adopted.

5. An evidentiary hearing is scheduled in this matter as follows:
