1. Paragraph 1 on page 1 of this Decision reads as:

On April 20, 2014, Public Medicare Transportation (Applicant or Public Service) filed its Application for a Certificate of Public Convenience and Necessity for the Pawnee to Daniels Park 345kV Transmission Project and for Specific Finding with Respect to EMF and Noise.

Paragraph 1 states that the application was filed on “April 20, 2014.” That is incorrect.

The application was filed on March 28, 2014. The applicant in paragraph 1 is shown as “Public Medicare Transportation.” That is incorrect. Public Service Company of Colorado is the applicant in this proceeding. Paragraph 1 shall be amended to read as follows:

On March 28, 2014, Public Service Company of Colorado (Applicant or Public Service) filed its Application for a Certificate of Public Convenience and Necessity for the Pawnee to Daniels Park 345kV Transmission Project and for Specific Finding with Respect to EMF and Noise.

2. The first sentence of paragraph 3 on page 1 of this Decision reads as:

The Commission gave notice of the application on April 23, 2012.

That sentence states that the application was noticed on “April 23, 2012.” That is incorrect.

The application was noticed on April 2, 2014. The first sentence of paragraph 3 shall be amended to read as follows:

The Commission gave notice of the application on April 2, 2014.

3. The hearing dates in ordering paragraph 6 on page 8 of this Decision are shown as:

DATE: September 6, 2012

TIME: 9:00 a.m.

DATE: September 6, 2012

TIME: 10:00 a.m.

That paragraph shows both hearing dates as “September 6, 2012.” That is incorrect. The hearing in this matter shall be held on September 9 and 10, 2014. The hearing dates in ordering paragraph 6 shall be amended to read as follows:

DATE: September 9, 2014

TIME: 9:00 a.m.

DATE: September 10, 2014

TIME: 10:00 a.m.
