GRANTING MOTION TO MODIFY PROCEDURAL
SCHEDULE AND WAIVING RESPONSE TIME**

I. STATEMENT

1. On June 26, 2014, Public Service Company of Colorado (Public Service) filed Advice Letter No. 124-Steam.
2. By Decision No. C14-0877, issued July 25, 2014, the effective date of the tariff was suspended and the matter was referred to an administrative law judge for disposition.
3. By Interim Decision No. R14-0899-I, issued on July 29, 2014, a prehearing conference was scheduled for August 26, 2014.
4. On August 5, 2014, Staff of the Colorado Public Utilities Commission (Staff) filed its Notice of Intervention as of Right, Entry of Appearance, Notice Pursuant to Rule 1007(a) and Rule 1403(b), and Request for Hearing.
5. On August 22, 2014, the Colorado Energy Office (CEO) filed its Motion for Permissive Intervention.

6. By Decision No. R14-1062-I, issued September 2, 2014, the intervention of the CEO was granted, the effective date of the advice letter was suspended until February 22, 2015, and a procedural schedule was adopted.

7. On September 22, 2014, Public Service filed its Motion to Modify Procedural Schedule (Motion). In the Motion, Public Service states that the parties have made significant progress in settlement negotiations and request that the deadline to file intervenor testimony be extended until October 1, 2014. Staff and the CEO do not oppose the Motion.

8. Good cause is found to grant the Motion.

II. ORDER

A. It Is Ordered That:

1. The Motion to Modify Procedural Schedule (Motion) filed by Public Service Company of Colorado on September 22, 2014 is granted.

2. The deadline for Intervenors to file testimony shall be extended until close of business on October 1, 2014. All other deadlines and the date for the evidentiary hearing remain unchanged.

3. Response time to the Motion is waived.

4. This Decision is effective immediately.
