GRANTING MOTION TO RESCHEDULE HEARING AND
ADOPTING A NEW PROCEDURAL SCHEDULE**

I. STATEMENT

1. On May 20, 2014, Carestream Health LLC (Carestream or Complainant) filed a Complaint against Xcel Energy, doing business as Public Service Company of Colorado (Public Service or Respondent). That filing commenced this proceeding.

2. On May 28, 2014, a hearing was set in this matter for August 11, 2014.

3. On May 28, 2014, by Minute Order, the Commission referred this matter to an Administrative Law Judge.

4. On June 17, 2014, Public Service filed their Answer to the Complaint (Answer). The Answer included both specific and general denials of the allegations in the Complaint and put this proceeding at issue.

5. On June 20, 2014, by Interim Decision No. R14-0673-I, the evidentiary hearing was vacated and a prehearing conference was scheduled for July 8, 2014. At the prehearing conference the parties agreed to a procedural schedule.

6. The procedural schedule called for an evidentiary hearing to be held November 19, 20, and 21, 2014.

7. On October 15, 2014, Carestream filed its Unopposed Motion to Reschedule Hearing.

8. On October 17, 2014, Public Service filed its Response to Unopposed Motion to Reschedule Hearing.

9. By Interim Decision No. R14-1283-I, issued October 24, 2014, a prehearing conference was scheduled for November 10, 2014 to discuss the status of the proceeding.

10. At the prehearing conference the parties agreed to a new procedural schedule:

II. ORDER

A. It Is Ordered That:

1. The Unopposed Motion to Reschedule Hearing, filed by Carestream Health LLC, on October 15, 2014 is granted.

2. The evidentiary hearing scheduled for November 19 through 21, 2014, is vacated

3. The evidentiary hearing in this matter is rescheduled as follows:
