**I. STATEMENT**

1. On April 14, 2014, Development Recovery Company LLC (DRC or Complainant) on behalf of the Ryland Group filed a Complaint against Public Service Company of Colorado (Public Service or Respondent). This filing commenced Proceeding No. 14F-0336EG.

2. On April 18, 2014 the Public Utilities Commission (Commission) issued an Order to Satisfy and Answer in Proceeding No. 14F-0336EG.

3. On April 23, 2014, by Minute Order, the Commission referred Proceeding No. 14F-0336EG to an Administrative Law Judge.

4. On April 24, 2014, DRC on behalf of Richmond American Homes of Colorado, Inc. filed a Complaint against Public Service. This filing commenced Proceeding No. 14F-0404EG

5. The procedural history of this proceeding is set out in previous Decisions and is repeated here as necessary to put this Decision in context.

6. By Interim Decision No. R14-0994-I issued on August 15, 2014, Proceeding No. 14F-0336EG was consolidated with Proceeding No. 14F-0404EG.

7. On December 3, 2014, the Complainant filed its Unopposed Proposal Procedural Schedule (Unopposed Proposal).

8. In the Unopposed Proposal the Complainant proposes the following procedural schedule:
