I. BY THE COMMISSION

A. Statement, Findings, and Conclusions

1. This matter comes before the Commission for consideration of a filing submitted on November 20, 2019, by DLT Transport LLC (Applicant), requesting that the Commission grant an extension of time, until February 15, 2020, to comply with the terms of Decision No. C19-0908 (Decision).

2. On September 18, 2019, Applicant filed an application for permanent authority to operate as a common carrier of passengers by motor vehicle for hire.

3. The Commission noticed the application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on September 23, 2019. The proceeding was uncontested; and thus, it was determined without a hearing.

4. On November 7, 2019, the Commission issued the Decision and granted the permanent authority, subject to Applicant's full compliance with the requirements contained in Ordering Paragraph No. 3 of the Decision.

5. Ordering Paragraph No. 3 of the Decision requires Applicant to file proof of insurance; pay the motor vehicle fee and issuance fee; submit an advice letter with tariff and a vehicle inspection report; and, register with the Commission's electronic filing system.

6. The Decision gave Applicant 60 days from its effective date to comply with each of these requirements. However, the Decision also states that for good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within 60 days of the effective date of the Decision.

7. The Decision became effective on November 7, 2019. Hence, Applicant has until January 6, 2020 to comply with the Decision or file a request for additional time.

8. The instant request for additional time was timely filed on November 20, 2019. It explains that "[t]he owner and her husband, the general manager of DLT, are leaving the United States on December 6, [2019] for a family and business trip to Ethiopia and will not return until January 12, 2020."

9. Therefore, the Commission concludes that good cause exists to extend the time for compliance with the requirements of the Decision until February 15, 2020.

II. ORDER

A. The Commission Orders That:

1. The request of DLT Transport LLC, filed on November 20, 2019, that the Commission grant an extension of time, until February 15, 2020, for it to complete the requirements set forth in Decision No. C19-0908 is granted.

2. DLT Transport LLC is granted until February 15, 2020 to complete the requirements set forth in Decision No. C19-0908.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

4. This Decision is effective on its Mailed Date.
