**I. BY THE COMMISSION**

**A. Statement, Findings, and Conclusions**

1. This matter comes before the Commission for consideration of a filing submitted on December 2, 2019, by Rapid Creek Cycles & Sports, LLC (Applicant), requesting that the Commission grant an additional 60 days to comply with the terms of Decision No. C19-0836 (Decision).

2. On July 17, 2019, Applicant filed an Application for permanent authority to operate as a common carrier of passengers by motor vehicle for hire.

3. The Commission noticed the Application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on August 26, 2019. The proceeding was uncontested; and thus, it was determined without a hearing.

4. On October 15, 2019, the Commission issued the Decision and granted the permanent authority, subject to Applicant's full compliance with the requirements contained in Ordering Paragraph No. 3 of the Decision.

5. Ordering Paragraph No. 3 of the Decision requires Applicant to file proof of insurance; pay the motor vehicle fee and issuance fee; submit an advice letter with tariff and a vehicle inspection report; and, register with the Commission's electronic filing system.

6. The Decision gave Applicant 60 days from its effective date to comply with each of these requirements. However, the Decision also states that for good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within 60 days of the effective date of the Decision.

7. The Decision became effective on October 15, 2019. Hence, Applicant had until December 16, 2019 (as the 60<sup>th</sup> day, December 14, 2019, was a Saturday) to comply with the Decision or file a request for additional time.

8. The instant request for additional time was timely filed on December 2, 2019. It explains: "Since getting the notice to proceed we are in the process of purchasing vans for the shuttle service. We are asking for 60 more days to complete the purchase, titling, registration and insurance process for these vans."

9. Therefore, the Commission concludes that good cause exists to extend the time for compliance with the requirements of the Decision for an additional 60 days from the original deadline.

## **II. ORDER**

### **A. The Commission Orders That:**

1. The request of Rapid Creek Cycles & Sports, LLC, filed on December 2, 2019, that the Commission grant an additional 60 days for it to complete the requirements set forth in Decision No. C19-0836 is granted.

2. Rapid Creek Cycles & Sports, LLC is granted until February 14, 2020 to complete the requirements set forth in Decision No. C19-0836.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an Application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

4. This Decision is effective on its Mailed Date.
