I. BY THE COMMISSION

A. Statement, Findings, and Conclusions

1. On November 15, 2019, Saint Vrain Shuttle, LLC filed an Application seeking authority to abandon a portion of Certificate of Public Convenience and Necessity (CPCN) No. 55927. The portion requested to be abandoned is the authority to operate between November 1st and April 30th.

2. The Commission noticed this Application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on November 25, 2019, for a period of ten days.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. In accordance with Rule 6205 of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* (CCR) 723-6, the information submitted with this Application warrants the granting of the requested partial abandonment.

5. The Commission finds that the Application for authority to abandon a portion of CPCN No. 55927 is in the public interest and will be granted.

6. With the abandonment of the authority to operate between November 1st and April 30th, Saint Vrain Shuttle, LLC will hereafter operate seasonally from May 1st through October 31st of each year. Therefore, CPCN No. 55927 will be revised accordingly and re-issued as a seasonal authority.

II. ORDER

A. The Commission Orders That:

1. This Application was deemed complete on December 11, 2019, within the meaning of § 40-6-109.5, C.R.S.

2. The Application filed by Saint Vrain Shuttle, LLC for approval to abandon that portion of Certificate of Public Convenience and Necessity (CPCN) No. 55927 which allows operations between November 1st and April 30th is granted.

3. CPCN No. 55927 will be re-issued as a seasonal certificate with authority as set forth in Appendix A attached to this Decision.

4. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

5. This Decision is effective on its Mailed Date.
