I hereby state that I will not disclose or disseminate sPower’s highly confidential information to any person other than those specifically authorized to review such highly confidential information by sPower and who have executed a non-disclosure agreement. I agree not to make any copies of any of kind of the highly confidential information subject to this non-disclosure agreement and to destroy the information at the conclusion of this proceeding.
