**I. BY THE COMMISSION**

**A. Statement, Findings, and Conclusions**

1. On December 12, 2019, Denver United Limousine LLC filed an application to abandon operations under Contract Carrier Permit No. B-10072.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on December 16, 2019, for a period of ten days.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. In accordance with Rule 6205 of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* 723-6, the information submitted with this application warrants the granting of the requested abandonment.

5. This application for approval to abandon Contract Carrier Permit No. B-10072 is in the public interest and will be granted.

**II. ORDER**

**A. The Commission Orders That:**

1. This application was deemed complete on January 2, 2020, within the meaning of § 40-6-109.5, C.R.S.
2. The application filed by Denver United Limousine LLC for approval to abandon operations under Contract Carrier Permit No. B-10072 is granted.
3. Contract Carrier Permit No. B-10072 is CANCELED.
4. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.
5. This Decision is effective on its Mailed Date.
