Energy Assistance System Benefit Charge

APPLICABILITY

All sales rate schedules for natural gas service, except for income-qualified customers and customers that request the removal of the monthly charge, are subject to the Energy Assistance System Benefit Charge (EASBC).

ENERGY ASSISTANCE SYSTEM BENEFIT CHARGE

The EASBC is in accordance with § 40-8.7-104(2.5), C.R.S., which requires the Company to bill and collect the monthly EASBC from natural gas sales customers and remit to Energy Outreach Colorado (EOC). These funds will be used towards low-income utility assistance and administered by the EOC.

CUSTOMER OPT OUT

Customers have the option to opt out of paying the monthly EASBC. Should a customer wish to have the charge removed from their monthly bill, the customer should contact the Company at 1-888-286-6700.

EFFECTIVE EASBC RATE – ALL SALES CUSTOMERS

Note: The monthly EAC charge shall adjust annually each October 1, beginning in 2023 the rate will adjust in accordance with the U.S. Dept. of Labor's Bureau of Labor Statistics Consumer Price Index for Denver-Aurora Lakewood.
