EVIDENTIARY HEARING WILL BE REMOTE AND
ADOPTING REMOTE HEARING PROCEDURES**

I. BY THE COMMISSION

A. Statement

1. On April 7, 2022, we issued Decision No. C22-0216-I which adopted a procedural schedule and set the evidentiary hearing for September 8-9, and 12-15, 2022. At the time of the decision we were unsure whether hearings would shift to being held in-person or use a hybrid approach and so we indicated that we would make that determination by separate decision.

2. We now confirm that the evidentiary hearing scheduled for September 8-9 and 12-15, 2022 will be conducted remotely.

3. The standard hearing procedures attached to Decision No. C22-0216-I are supplemented by the remote hearing procedures in Attachment A to this Decision.

II. ORDER

A. It Is Ordered That:

1. The *en banc* remote evidentiary hearing in this Proceeding is scheduled as follows:

- DATES:** September 8-9 and 12-15, 2022
- TIMES:** 9:00 a.m. until concluded, but no later than 5:00 p.m. on September 8, 9, 12, 13, and 15; and 1:00 p.m. until concluded, but no later than 5:00 p.m. on September 14
- WEBCAST:** Commission Hearing Room A
- PLACE:** Join by video conference using Zoom.

2. Commission Staff will provide the parties with a Zoom link closer to the start of the hearing. The parties are responsible for sharing the link, meeting ID code, and passcode to witnesses and others participating in the hearing. Participants in the hearing may not distribute the link, meeting ID code, and passcode to anyone not participating in the hearing. Unless otherwise ordered, the parties and witnesses may not appear in person at the Commission for the above-scheduled hearing. Instead, parties and witnesses will participate in the hearing from remote locations, consistent with the requirements of this Decision.

3. All participants must comply with the requirements in Attachment A to Decision No. C22-0216-I and Attachment A to this Decision.

4. The parties and witnesses are required to participate in the evidentiary hearing by video conference using Zoom. The parties must ensure that they and their witnesses are ready and able to participate in the evidentiary hearing by video conference, including presenting evidence electronically during the hearing using Zoom.

5. This Decision is effective upon its Mailed Date.
