This notification to CenturyLink's CLEC customers in the state of Colorado is to provide advance notice of our intent to file for removal of the following exhibits from this states' interconnection agreements: Exhibit B - Performance Indicator Definitions (PID) and Exhibit K – Performance Assurance Plan (PAP). We anticipate filing with the state's commission to occur in early February 2022.

CenturyLink continually analyzes declining/low volumes, the changing communications business, and current regulatory environment against the original intent of these metrics. At this point volumes are so low, continue to decline, and communications with CLECs about the measurements are so rare that we believe the PAP and PIDs no longer serve a useful function.

CenturyLink has either met with or attempted to meet with CLECs that still have the most volume of services measured by the PID or PAP in Colorado to address any issues or concerns and have received no objection from them to this proposed action.
