I. <u>BY THE COMMISSION</u>

A. Statement

1. The Colorado Public Utilities Commission (Commission) issues this Notice of

Proposed rulemaking to amend the Rules Regulating Telecommunications Services and Providers

of Telecommunications Services contained in 4 Code of Colorado Regulations (CCR) 723-2-2150,

2802, and 2827 (Surcharge Remittance Rules).

2. The changes proposed are intended to eliminate the existing requirement that

telecommunications service providers complete and file a remittance form for the 9-1-1 surcharge,

the 988 surcharge, and the telecommunications relay service (TRS) surcharge with the

Commission, and to instead require that the providers complete a return and submit payment as

directed by Commission Staff. This will allow providers to submit their return and submit payment

in one step, in most cases. Changes made to Rule 2150, which prescribes the procedures for

remittance of 9-1-1 surcharges, are repeated in Rules 2802 and 2827 for the 988 surcharge and the TRS surcharge, respectively.

- 3. The effective date of these rules would be January 1, 2024. Should comment or other processes extend this rulemaking such that any proposed updates to rules cannot be effective by January 1, 2024, we seek comment on a future date certain that could assist in the implementation of updated processes.¹
- 4. These changes are being proposed to streamline the remittance process for the telecommunications service providers, eliminate unnecessary paperwork, and enhance the ability of Commission staff to track remittances and ensure accountability.
- 5. In addition to proposed updates regarding form submission, we also provide limited updates regarding remittance timelines. Specifically, we propose to require that remittances be completed by the last day of the month following the month in which the surcharge was collected from the consumer, even if the last day of the month is on a weekend or holiday. This update is intended to make clear that Rule 1203(a), 4 CCR 723-1 of the Commission's Rules of Practice and Procedure, which continues deadlines to the end of the next business day if that deadline falls on a weekend or holiday, does not apply. Telecommunications service providers may submit payment prior to the last day of the month (*e.g.*, on the last business day if the month ends on a holiday or weekend), but all submissions must be provided by the last calendar day of the month under the proposed rule. This change is being proposed to remove ambiguity regarding when late penalties and interest are to be assessed.

¹ For example, while we do not at this time anticipate multiple public comment hearings will be necessary, if more than one public comment hearing is held, the date certain of January 1, 2024, may need to be extended.

June 10, 2023, edition of *The Colorado Register*.

recommended decision.
