AND ACCEPTING LATE-FILED COMPLIANCE ITEM**

I. BY THE COMMISSION

A. Statement, Findings, and Conclusions

1. This matter comes before the Commission for consideration of a filing submitted on June 30, 2023, by eTuk Denver LLC, doing business as eTuk Ride (Applicant), requesting that the Commission reopen the proceeding and accept the late-filed compliance items.

2. On September 8, 2022, Applicant filed an application for permanent authority to extend operations under Certificate of Public Convenience and Necessity PUC No. 55861.

3. On November 9, 2022, the Commission issued Decision No. C22-0702 (Decision) and granted the unopposed application. In Ordering Paragraph No. 3, the Decision set forth certain requirements, such as filing a new advice letter with tariff, that were to be completed within 60 days of the Decision's effective date.

4. By Decision No. C22-0840, issued on December 28, 2022 in this proceeding, the compliance deadline was extended until April 27, 2023. A review of Commission records shows

that the compliance items were timely submitted except for the advice letter and tariff, which were filed on May 8, 2023. As a result, this proceeding was closed without the extended authority being issued.

5. In the filing submitted on June 30, 2023, Applicant requests that the proceeding be reopened and the late-filed compliance items accepted.

6. The Commission concludes that good cause exists to reopen the proceeding in order to extend the time for compliance with the Decision and accept the late-filed advice letter and tariff. This will allow the extended authority to be issued without Applicant having to file another application.

II. ORDER

A. The Commission Orders That:

1. The request of eTuk Denver LLC, doing business as eTuk Ride, filed on June 30, 2023, that the Commission reopen the proceeding and accept the late-filed compliance items, is granted.

2. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

3. This Decision is effective on its Mailed Date.
