I. <u>BY THE COMMISSION</u>

A. Statement, Findings, and Conclusions

- 1. On July 26, 2024, Biodiesel for Bands, doing business as Planetary Transport Company, filed an Application seeking approval to suspend operations under its authority, Certificate of Public Convenience and Necessity ("CPCN") PUC No. 55907, from July 26, 2024 through March 30, 2025.
- 2. The Commission noticed this Application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on July 30, 2024, for a period of ten days.
- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This Proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

- 4. In accordance with Rule 6205 of the Rules Regulating Transportation by Motor Vehicle, 4 Code of Colorado Regulations 723-6, the information submitted with this Application warrants the granting of a Suspension of Operations.
- 5. The Application for Authority to Suspend CPCN PUC No. 55907, is not contrary to the public interest and will be granted.

II. **ORDER**

The Commission Orders That: Α.

- 1. This Application is deemed complete for purposes of § 40-6-109.5, C.R.S.
- 2. The Application filed by Biodiesel for Bands, doing business as Planetary Transport Company, for authority to suspend operations under Certificate of Public Convenience and Necessity ("CPCN") PUC No. 55907, is granted, nunc pro tunc, from July 26, 2024 through March 30, 2025.
 - 3. On March 31, 2025, CPCN PUC No. 55907 shall be administratively reactivated.
- 4. Prior to commencing operations, Biodiesel for Bands, doing business as Planetary Transport Company, shall: (a) cause proof of insurance or surety bond coverage to be filed with the Commission pursuant to Rule 6008, 4 Code of Colorado Regulations 723-6; (b) pay to the Commission the applicable vehicle identification fee for each vehicle to be operated under authority granted by the Commission; and, (c) ensure that an effective tariff is on file with the Commission, in compliance with applicable Commission rules.
- 5. The 20-day period provided for in § 40-6-114, C.R.S., within which to file an Application for Rehearing, Reargument, or Reconsideration begins on the first day following the effective date of this Decision.

6. This Decision is effective immediately on its Issued Date.
