I. <u>BY THE COMMISSION</u>

A. Statement

1. On July 17, 2024, the Commission gave notice that the above-styled proceeding had been opened, directing each telecommunications service provider to file the Colorado High-Cost Support Mechanism ("HCSM") Worksheet for the reporting period of January 1, 2024, through June 30, 2024, due by September 1, 2024. The Director's letter allows for the filing of a motion for an extension of time, for a period not to exceed 30 days if good cause is shown.

2. On September 11, 2024, Rye Telephone Company ("Rye") filed a Motion for Extension of Time ("Motion") to file its HCSM Worksheet for the reporting period of January 1, 2024, through June 30, 2024, with the Commission.

3. Rye is working with the Commission's High-Cost vendor, Rolka Loube, to submit the HCSM Worksheet. Rye requests an extension of time to submit its HCSM Worksheet by September 20, 2024.

4. This miscellaneous proceeding is not contested. Therefore, response time to the Motion will be waived pursuant to Rule 1400(b) of the Rules of Practice and Procedure, 4 *Code of Colorado Regulations* 723-1.

5. The Motion states good cause, and the requested extension of time until September 20, 2024, will be granted.

6. On September 19, 2024, Rye submitted its HCSM Worksheet with the Commission's High-Cost vendor, Rolka Loube.

II. ORDER

A. The Commission Orders That:

1. The Motion for an Extension of Time to file the HCSM Worksheet filed by Rye Telephone Company is granted, *nunc pro tunc*, through September 20, 2024. Decision No. C24-0726
