#### I. <u>BY THE COMMISSION</u>

#### A. Statement, Findings, and Conclusions

1. On October 25, 2024, WeDriveU, Inc. filed an Application to abandon operations under Contract Carrier Permit Nos. B-10094 and B-10098.

2. The Commission noticed this Application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on October 28, 2024, for a period of ten days.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. In accordance with Rule 6205 of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* 723-6, the information submitted with this Application warrants the granting of the requested abandonment.

5. This Application for approval to abandon Contract Carrier Permit Nos. B-10094 and B-10098, is not contrary to the public interest and will be granted.

#### II. ORDER

#### A. The Commission Orders That:

- 1. This Application is deemed complete for purposes of § 40-6-109.5, C.R.S.
- 2. The Application filed by WeDriveU, Inc. for approval to abandon operations under

Contract Carrier Permit Nos. B-10094 and B-10098, is granted.

- 3. Contract Carrier Permit Nos. B-10094 and B-10098 are CANCELLED.
- 4. The 20-day period provided for in § 40-6-114, C.R.S., within which to file an

Applications for Rehearing, Reargument, or Reconsideration begins on the first day following the

effective date of this Decision.

5. This Decision is effective immediately on its Issued Date.
