I. BY THE COMMISSION

A. Statement, Findings, and Conclusions

1. This matter comes before the Commission for consideration of a motion submitted on February 24, 2025, by CCT Holdings Limos, LLC, doing business as Colorado Cannabis Tours (“Applicant”), requesting the Commission grant an additional 30 days to comply with the terms of Decision No. R24-0935 (“Decision”).

2. On September 27, 2024, Applicant filed an Application for permanent authority to extend operations under its Certificate of Public Convenience and Necessity (“CPCN”) PUC No. 55977.

3. The Commission noticed the application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on October 8, 2024. Interventions were filed and the proceeding was referred to an Administrative Law Judge (“ALJ”).

4. On December 30, 2024, the ALJ issued the Decision and granted the Application, subject to Applicant's full compliance with the requirements contained in Ordering Paragraph No. 9 of the Decision.

5. Ordering Paragraph No. 9 of the Decision requires Applicant to file proof of insurance; pay the motor vehicle fee and issuance fee; and submit an advice letter with tariff.

6. The Decision gave Applicant 60 days from its effective date, or until March 20, 2025, to comply with each of these requirements. For good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within 60 days of the effective date of the Decision.

7. On February 24, 2025, Applicant timely filed the instant motion for an additional 30 days to comply with the Decision. Applicant states the following:

Good cause exists to grant additional time because the Applicant has been diligently working to complete the required compliance items since the Decision was issued and is close to submitting the applicable filings. Specifically, the Applicant has been developing a new Tariff that incorporates a new type of service (Scheduled service) for the Applicant compared to its existing call-and-demand transportation offerings and authority. As a new and distinct type of service, the Applicant desires to ensure that its Tariff complies with the legal requirements for Scheduled service discussed in the Decision and with all other applicable Commission rules.

8. The Commission concludes that good cause exists to grant Applicant's request for an extension of 30 days to comply with the Decision.

II. ORDER**A. The Commission Orders That:**

1. The motion submitted by CCT Holdings Limos LLC, doing business as Colorado Cannabis Tours, on February 24, 2025, requesting that the Commission grant an additional 30 days for it to complete the requirements set forth in Decision No. R24-0935, is granted.

2. CCT Holdings Limos LLC, doing business as Colorado Cannabis Tours, is granted 30 days from the original deadline of March 20, 2025, or until April 19, 2025, to comply with the requirements set forth in Decision No. R24-0935.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

4. This Decision is effective upon its Issued Date.
