I. **BY THE COMMISSION**

> Α. Statement, Findings, and Conclusions

On April 1, 2025, Public Service Company of Colorado ("Public Service" or 1.

the "Company") filed a Motion for Commission Approval of an Alternative Form of Notice

("Motion") to apply to Public Service's Advice Letter and tariff filing to revise its Colorado P.U.C.

No. 6-Gas tariff to implement a revised Gas Demand-Side Management Cost Adjustment

("DSMCA-G") tariff to implement a revision in the DSMCA-G components effective July 1, 2025.

2. Public Service moves pursuant to § 40-3-104(1)(c)(I)(E), C.R.S., and Rule 1207(b),

4 Code of Colorado Regulations ("CCR") 723-1, to provide alternative forms of notice for the

Company's filing to its customers. Public Service requests Commission approval to use the

following forms of notice:

Posting the customer notice on the Company's Rates and Regulations website

pursuant to § 40-3-104(1)(c)(I), C.R.S.

- Publishing a digital ad, for one full day in *The Denver Post*, and for one week in *The Colorado Sun*.
- Electronic service of the Advice Letter and associated tariffs on all parties in Proceeding Nos. 23A-0392EG, the first Clean Heat Plan proceeding, and 23A-0589EG, the 2024-2026 DSM/BE Plan.
- 3. Public Service maintains that good cause exists for the Commission to approve the proposed alternative forms of notice, and this will avoid incurring the expenses associated with other forms of statutory notice. The Company concludes the proposed alternative forms of notice will be sufficient to alert affected and interested parties to the changes the Company is proposing.
- 4. Pursuant to § 40-3-104(1)(c)(I)(E), C.R.S., and 4 CCR 723-1-1207(b) of the Commission's Rules of Practice and Procedure, a utility may request to provide alternative forms of notice of a tariff change. We find the alternative forms of notice the Company proposes in the Motion will provide sufficient notice in an efficient manner. We therefore find good cause to approve the alternative forms of notice that the Company requests.

II. ORDER

A. It Is Ordered That:

1. The Motion for Commission Approval of an Alternative Form of Notice, filed by Public Service Company of Colorado on April 1, 2025, is granted.
