I. **BY THE COMMISSION** 

> A. Statement

On April 11, 2025, Public Service Company of Colorado ("Public Service" or the 1.

"Company"), on behalf of all parties to this proceeding, provided notice to the Commission that a

settlement in principle among all the parties in this proceeding had been reached. Public Service

stated that the parties had reached a settlement in principle to all contested issues and were working

to memorialize the settlement in a document to be subsequently filed with the Commission for

approval.

2. In light of this development, the Company requested the Commission amend the

procedural schedule previously approved in Decision No. C24-0761-I, issued October 23, 2024,

which among other things, set forth a procedural schedule that included a deadline of

April 18, 2025 to file a settlement agreement, and a deadline of April 24, 1015 to file testimony in support of a settlement agreement.

3. Public Service requested the deadline to file a settlement agreement be extended to April 18, 2025, and the deadline to file supporting testimony be extended to April 28, 2025. Additionally, Public Service requests response time to this motion be waived as the motion was unopposed.

## В. Conclusion

4. We find good cause to grant the request sought by Public Service. Therefore, we will extend the deadline to file a settlement agreement from April 14, 2025, to April 18, 2025. Additionally, we will extend the deadline to file testimony in support of a settlement agreement from April 24, 2025, to April 28, 2025. As Public Service's motion is unopposed, response time to the motion will also be waived.

## II. **ORDER**

## Α. It Is Ordered That:

- The motion of Public Service Company of Colorado ("Public Service") to Amend 1. Procedural Schedule and Request for Waiver of Response Time ("Motion") is granted consistent with the discussion above.
- 2. The Motion to extend the deadline to file a settlement agreement in this Proceeding is extended from April 14, 2025, to April 18, 2025.
- 3. The Motion to extend the deadline to file testimony in support of a settlement agreement in this Proceeding is extended from April 24, 2025, to April 28, 2025.
