**I. BY THE COMMISSION**

**A. Statement, Findings and Conclusions**

1. On May 12, 2025, Public Service Company of Colorado (“Public Service” or the “Company”) filed its Application for Approval of its 2026-2027 Renewable Energy Compliance Plan (“RE Plan”) (“Application”).

2. Pursuant to § 40-6-109.5, C.R.S., and Rule 1303, 4 *Code of Colorado Regulations* 723-1, this Application will automatically deem complete on July 1, 2025, unless the Commission takes action prior to that date.

3. The Commission finds that further time is necessary to address the determination of completeness under Rule 1303(c). Due to the press of business, we find that ensuring the Application does not auto-deem complete is appropriate. Pursuant to Commission Rule 1003, we find good cause to issue a variance to the timing parameters found in Rule 1303.

4. The Commission will determine completeness of the Application for purposes of § 40-6-109.5, C.R.S., at a future date.

**II. ORDER**

**A. The Commission Orders That:**

1. The determination pursuant to § 40-6-109.5, C.R.S. regarding the completeness of the Application for Approval of its 2026-2027 Renewable Energy Compliance Plan (“Application”) filed on May 12, 2025, by Public Service Company of Colorado is delayed to a future date. The Application shall not auto-deem complete on July 1, 2025.

2. This Decision is effective immediately upon its Issued Date.
