EXTENSION OF TIME**

I. BY THE COMMISSION

A. Statement, Findings, and Conclusions

1. This matter comes before the Commission for consideration of a letter submitted on June 17, 2025, by George Mugerian, the president of Quick Car LLC (“Applicant”), requesting that the Commission grant additional time for the company to comply with the terms of Decision No. R25-0267 (“Decision”).

2. On November 21, 2024, Applicant filed an Application for Permanent Authority to Operate as a Common Carrier of Passengers by Motor Vehicle For Hire.

3. The Commission noticed the Application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on December 2, 2024. Interventions were filed and the proceeding was referred to an Administrative Law Judge (ALJ).

4. On April 9, 2025, the Commission issued the Decision and granted the Application, as amended, subject to Applicant's full compliance with the requirements contained in Ordering Paragraph No. 7 of the Decision.

5. Ordering Paragraph No. 7 of the Decision requires Applicant to file proof of insurance; pay the motor vehicle fee and issuance fee; submit an Advice Letter with Tariff and vehicle inspections, and register in the Commission's electronic filing system.

6. The Decision gave Applicant 60 days from its effective date to comply with each of these requirements. For good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within 60 days of the effective date of the Decision.

7. On June 17, 2025, Applicant timely filed the instant request, which states: "I hereby request an extension of the deadline to submit compliance items to 11/15/2025. The van we are using is a special order and we are waiting for the vehicle to be built and shipped."

8. The Commission concludes that good cause exists to grant Applicant until November 15, 2025, to comply with the Decision.

II. ORDER

A. The Commission Orders That:

1. The filing submitted by Quick Car LLC, on June 17, 2025, requesting that the Commission grant additional time for it to complete the requirements set forth in Decision No. R25-0267, is granted.

2. Quick Car LLC is granted until November 15, 2025, to comply with the requirements set forth in Decision No. R25-0267.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an Application for Rehearing, Reargument, or Reconsideration shall begin on the first day after the Commission mails or serves this Decision.

4. This Decision is effective immediately upon its Issued Date.
