# COMMISSION DECISION GRANTING MOTION FOR EXTENSION OF TIME

### I. <u>BY THE COMMISSION</u>

#### A. Statement

1. This matter comes before the Commission for consideration of a request for an extension of time filed on behalf of Ezee Fiber Texas, LLC. ("Ezee Fiber") on July 8, 2025. We shall construe this filing as a Motion for Extension of Time to File a Surety Bond ("Motion").

2. In Decision No. C24-0502 (issued July 11, 2024), the Commission granted Ezee Fiber's Application for a Certificate of Public Convenience and Necessity ("CPCN") with conditions.

That Decision, in  $\P$  9 states:

With the issuance of this authority, Ezee Fiber must: (1) file a bond or letter of credit consistent with the terms and conditions in Attachment A and AA to this Decision; and (2) comply with all applicable statutory and regulatory requirements pursuant to Rule 2103(a)(XVI), 4 CCR 723-2.

Decision No. C25-0545

Paragraph 5 of the Decision states:

If Ezee Fiber fails to file financial assurance within one year from the Mailed Date of this Decision, this CPCN to provide Part IV services shall be deemed null and void without further action of the Commission. For good cause shown, and if a proper request is filed within one year of the Mailed Date of this Decision, the Commission may grant additional time within which to file financial assurance.

3. In its Motion, Ezee Fiber states that it has been working towards obtaining the bond

or letter of credit requirement and requests an additional 60 days to secure the necessary bond or

letter of credit. The Commission finds good cause exists to grant the Motion and waive response

time thereto.

4. On July 15, 2025, Ezee Fiber filed the bond as required by Decision No. C24-0502.

## II. <u>ORDER</u>

## A. The Commission Orders That:

1. The Motion for Extension of Time to File a Surety Bond, filed by Ezee Fiber, is granted, and response time thereto is waived. Ezee Fiber on July 16, 2025, shall have until September 16, 2025, to file its financial assurance, consistent with the requirements included in Decision No. C24-0502.
