<p>COLORADO LAW Permit Required</p> <p>Lawful Presence in United States</p>	<p>Colorado law requires that towing carriers must obtain a permit from the Public Utilities Commission (PUC) prior to beginning service. An existing carrier applying to change its business structure (e.g., sole proprietorship to LLC, etc) is required to re-apply and pay all applicable fees.</p> <p>Colorado law requires that only persons lawfully present in the United States may be issued a license, certificate, registration or permit. If you are a sole proprietorship, you must complete the attached Affidavit of Eligibility. When requested, you must produce valid identification.</p>
<p>APPLICATION REQUIREMENTS</p>	<p>The non-refundable application fee is \$150.00.</p> <p>This application, fee, and attachments may be filed with the PUC by mail or personal delivery to: Colorado Public Utilities Commission, 1560 Broadway, Suite 250, Denver, CO 80202.</p> <p>Fees may be paid by cash, credit card, money order, or check. (Make checks payable to the Colorado Public Utilities Commission.)</p> <p>If the applicable fees are paid by credit card, then the application and required attachments may be filed with the PUC by fax at 303-894-2071.</p> <p style="padding-left: 40px;">NOTE: An additional \$4.00 or 3% fee, whichever is greater, shall be charged for every credit card transaction.</p> <p>If you need further information or assistance, please call (303) 894-2000 and select option 4. Incomplete applications may be returned for correction.</p>
<p>ANNUAL FEE</p>	<p>The annual fee is \$5.00 per vehicle for tow carriers, which expires each December 31.</p> <p>Please indicate the number of towing vehicles to be operated: _____</p> <p>A carrier is not subject to the annual fee if it has registered and paid a fee as an interstate motor carrier under the Unified Carrier Registration Agreement (UCR) for the current year for each vehicle operated (including those to be operated under this permit). To verify UCR, please indicate your USDOT number in the section below.</p>

AFFIDAVIT OF ELIGIBILITY – SOLE PROPRIETOR

Acceptable Identification Document Types

1. Valid Colorado driver's license or identification card (includes only a current driver's license, minor driver's license, probationary driver's license, commercial driver's license, restricted driver's license, instruction permit or identification card).
2. Valid driver's license or identification card bearing applicant's photograph issued by one of the following states:
Alabama, Arizona, Arkansas, California, Connecticut, Delaware, District of Columbia, Florida, Georgia, Idaho, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Minnesota, Mississippi, Missouri, Montana, Nevada, New Hampshire, New Jersey, New York, North Dakota, Ohio, Oklahoma, Pennsylvania, Rhode Island, South Carolina, South Dakota, Virginia, West Virginia, and Wyoming.

Note: A driver's license or identification card from any state not listed above is not acceptable verification because the missing states do not verify lawful presence in the United States as part of the issuance process.
3. Valid United States military card or a military dependent's identification card.
4. United States Coast Guard Merchant Mariner card.
5. Native American tribal document.
6. Certificate verifying naturalized status issued by an authorized agency of the United States bearing applicant's intact photograph impressed with the raised embossed seal of the issuing agency.
7. Certificate verifying United States citizenship issued by an authorized agency of the United States bearing applicant's intact photograph impressed with the raised embossed seal of the issuing agency.
8. Any of the following valid immigration documents demonstrating lawful presence and verified through the Systematic Alien Verification for Entitlements (SAVE) Program administered by the United States Citizenship and Immigration Services of the Federal Department of Homeland Security:
 - a. Unexpired foreign passport bearing an unexpired "Processed for I-551" stamp or with an attached unexpired "Temporary I-551"
 - b. Unexpired foreign passport accompanied by an "I-94" indicating a specific future "until" date.
 - c. "I-94" with refugee or asylum status.
 - d. Unexpired "Resident Alien" card, "Permanent Resident" card, "Temporary Resident" card, or "Employment Authorization" card.
