I. <u>BY THE COMMISSION</u>

A. Statement

1. This matter comes before the Commission for consideration of a Motion for

Extension of Time to Install a Queue Cutter Signal (Motion) filed by the City of Commerce City

("Commerce City") on May 30, 2024, requesting an extension of time to December 31, 2024, to

install the queue cutter signal ordered by the Commission in Decision No. C23-0817 mailed

December 8, 2023.

2. As grounds, Commerce City states that the complexity of the improvements and

design required both Commerce City and the Colorado Department of Transportation ("CDOT")

to strictly adhere to their procedures and processes to prepare and approve the required plans.

While Commerce City and CDOT have been working diligently to meet the June 30, 2024

deadline, the complexity of the necessary improvements, including the railroad preemption

design, railroad signal design, CDOT permitting and railroad permitting, the completion of the project is taking longer than is typical. Commerce City requests an additional extension of time to December 31, 2024, to complete the construction and provide the letter of completion required by the Commission.

- 3. No responses to the Motion were received.
- 4. Now being fully advised in the matter, we grant the Motion.

## II. ORDER

## **A.** The Commission Orders That:

- 1. The Motion for Extension of Time to Install a Queue Cutter Signal ("Motion") filed by the City of Commerce City ("Commerce City") on May 30, 2024, requesting an extension of time to December 31, 2024, to install the queue cutter signal ordered by the Commission in Decision No. C23-0816 mailed December 8, 2023, is granted.
- 2. Commerce City shall file a letter of project completion in this proceeding by December 31, 2024.
