**I. BY THE COMMISSION**

**A. Statement, Findings, and Conclusions**

1. This matter comes before the Commission for consideration of a request for an extension of time filed on behalf of CBTS Borrower, LLC (“CBTS Borrower”), Cincinnati Bell, Inc. (“Cincinnati Bell”), and CBTS Technology Solutions, LLC (“CBTS-TS”) on July 3, 2024.

2. We shall construe this filing as a Motion for Extension of Time to complete the Transaction related to the indirect transfer of control of CBTS-TS to CBTS Borrower in Decision No. C24-0310 (issued May 10, 2024), in which the Commission granted the referenced Joint Application to Execute a Transfer. The decision required the Applicants to jointly notify the Commission if the Transaction has not been completed within 60 days of the proposed effective date stated in the Joint Application.

3. In its Motion, the Applicants state that the closing is expected by the second half of 2024. Applicants request that the Commission approve an extension of time to

December 31, 2024, allowing additional time to secure the necessary authorizations to complete the Transaction.

**II. ORDER**

**A. The Commission Orders That:**

1. The Motion for Extension of Time to Complete the Transaction, filed by the Applicants is granted. Applicants shall have until December 31, 2024, to complete the Transaction, consistent with Decision No. C24-0310.

2. This Decision is effective on its Issued Date.
