I. <u>BY THE COMMISSION</u>

A. Statement, Findings, and Conclusions

- 1. On July 25, 2024, Casa De Adult Day Care Inc. filed an Application to abandon operations under Contract Carrier Permit No. B-9888.
- 2. The Commission noticed this Application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on July 30, 2024, for a period of ten days.
- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
- 4. In accordance with Rule 6205 of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* 723-6, the information submitted with this Application warrants the granting of the requested abandonment.
- 5. This Application for approval to abandon Contract Carrier Permit No. B-9888, is not contrary to the public interest and will be granted.
