**I. BY THE COMMISSION**

**A. Statement, Findings, and Conclusions**

1. This matter comes before the Commission for consideration of a letter submitted on October 25, 2024, by The Scion Group LLC (“Applicant”), requesting that the Commission grant an extension of time to comply with the terms of Decision No. C24-0718 (“Decision”).

2. On August 2, 2024, Applicant filed an application for new permanent authority to operate as a contract carrier of passengers by motor vehicle for hire.

3. The Commission noticed the application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on August 12, 2024. This proceeding was uncontested; and thus, it was determined without a hearing.

4. On October 4, 2024, the Commission issued the Decision and granted the application, subject to Applicant's full compliance with the requirements contained in Ordering Paragraph No. 3 of the Decision.

5. Ordering Paragraph No. 3 of the Decision requires Applicant to file proof of insurance; pay the motor vehicle fee and issuance fee; submit an advice letter with tariff and a vehicle inspection; and register with the Commission's electronic filing system.

6. The Decision gave Applicant 60 days from its effective date of October 4, 2024, to comply with each of these requirements. For good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within 60 days of the effective date of the Decision.

7. On October 25, 2024, Applicant timely filed the instant request for additional time to comply with the Decision. Applicant states as the reason for the request:

We have run into an issue filing the Form E because the shuttle is in the owner's name and rented to The Scion Group LLC for use. Since Scion is the drivers and users of the shuttle, the application is in the name of The Scion Group LLC, but the first named insured is the shuttle owner. Every time we try and file the Form E it is rejected since the first named insured is not the applicant.

We are trying to resolve this and need additional time to resolve.

8. The Commission concludes that good cause exists to grant Applicant an additional 45 days from the original deadline, or until January 17, 2025, to comply with the Decision.

## **II. ORDER**

### **A. The Commission Orders That:**

1. The filing submitted by The Scion Group LLC on October 25, 2024, requesting that the Commission grant an extension of time for it to complete the requirements set forth in Decision No. C24-0718, is granted.

2. The Scion Group LLC is granted an additional 45 days from the original deadline, or until January 17, 2025, to comply with the requirements set forth in Decision No. C24-0718.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

4. This Decision is effective immediately upon its Issued Date.
