**I. STATEMENT**

**A. Procedural Background**

1. On December 1, 2023, Tri-State Generation and Transmission Association, Inc. filed an Application for Approval of its 2023 Electric Resource Plan (Application). Filing of the Application commenced this Proceeding.

2. By Decision No. R24-0080-I, issued February 6, 2024, the undersigned Administrative Law Judge (ALJ), among other things, granted Moffat County's and the City of Craig, Colorado's (together, Moffat/Craig) motions to permissively intervene in this Proceeding.

3. On April 3, 2024, Moffat/Craig filed the Unopposed Motion of Moffat County and the City of Craig Requesting the Scheduling of a Public Comment Hearing (Motion Requesting Public Comment Hearing).

4. By Decision No. R24-0319-I, issued May 9, 2024, the undersigned ALJ granted the Motion Requesting Public Comment Hearing, scheduled an in-person Public Comment Hearing in Craig for July 9, 2024 from: 3:00 p.m. to 6:00 p.m. (with an exact location to be noticed in a future decision), and scheduled a virtual public comment hearing for July 11, 2024, from 4:00 p.m. to 6:00 p.m.

**B. Participating in the In-Person Public Comment Hearing**

5. As stated in Decision No. R24-0319-I, the July 9, 2024, public comment hearing was scheduled. By this decision, the scheduled time will be extended. The hearing will be conducted in-person in Craig, Colorado, as follows:

**DATE:** Tuesday, July 9, 2024.

**TIME:** 3:00 p.m. until 7:00 p.m.

*Please note that the hearing will conclude upon completion of public comments, but no earlier than 6:00 p.m.*

12. To ensure a clear record and orderly hearing progression, interested persons are strongly encouraged to participate in the virtual public comment hearing by videoconference. Nevertheless, interested persons have the option to participate by telephone only without video.

13. During the virtual public comment hearing, the ALJ will take action as necessary to facilitate a clear and understandable record, and to ensure the orderly progress of the hearing. For the same reasons, all participants are requested to: (a) mute their microphone during the hearing until called upon by the ALJ; (b) ensure they are participating from a location with minimal or no background noise; (c) not connect to the hearing using multiple devices located in the same room (which causes audio feedback); and (d) input their full name into Zoom when prompted to do so. Participants are encouraged to use a headset to listen to the hearing, as this may also help avoid background noise and feedback when they speak. Participants are encouraged to use a computer, smart phone, or tablet that is connected to the internet and has an operational microphone, speaker, and camera.

14. Attachment A to this Decision provides step-by-step technical instructions and requirements to participate by videoconference using a computer. This is intended to ensure that the remote hearing proceeds efficiently. Hence, it is important that videoconference participants carefully review and follow all requirements in this Decision and Attachment A.

15. Consistent with Commission practice, the virtual public comment hearing on July 11, 2024, will be webcasted on the Commission's YouTube channel. Persons wishing to observe, but not participate in the hearing may do so by observing the webcast of the rulemaking hearing and need not join the hearing by telephone or videoconference.
