# INTERIM DECISION OF ADMINISTRATIVE LAW JUDGE ALENKA HAN SETTING PUBLIC COMMENT HEARING

Mailed Date: June 6, 2024

## I. <u>STATEMENT, SUMMARY, AND BACKGROUND</u>

## A. Summary

1. This Decision schedules a remote public comment hearing on Thursday, September 19, 2024, from 11:30 a.m. to 1:30 p.m. and from 4:00 p.m. to 6:00 p.m.

## B. Procedural Background

- 2. On March 1, 2024, Atmos Energy Corporation (Atmos) filed its initial Gas Infrastructure Plan (GIP). Atmos made the filing consistent with provisions in the Colorado Public Utilities Commission's (Commission or PUC) Rules Regulating Gas Utilities, 4 *Code of Colorado Regulations* (CCR) 723-4-4550 to 4555, that require the filing of GIPs as part of the Commission's updated regulatory framework for gas utilities, adopted through Proceeding No. 21R-0449G.
- 3. By Decision No. C24-0259, issued April 22, 2024, the Commission opened this Proceeding, established procedures for this Proceeding, and referred the scheduling and convening of a public comment hearing in this matter to an Administrative Law Judge (ALJ). The matter was subsequently assigned to the undersigned ALJ.

4. By Decision No. C24-0360-I, issued May 28, 2024, the Commission determined that the parties to this Proceeding are Atmos, Trial Staff of the Public Utilities Commission (Staff), the Office of the Utility Consumer Advocate (UCA), and the Colorado Energy Office (CEO).

#### II. FINDINGS, CONCLUSIONS, AND ANALYSIS

- Atmos uses its gas distributions system to deliver natural gas to approximately 5. 126,000 customers in noncontiguous areas across the state, spanning from Greeley and surrounding areas in the northeast; Steamboat Springs, Craig, and Meeker in the northwest; Salida, Gunnison, and Crested Butte; Canon City in central Colorado; Lamar and many small communities in the southeast corner; and the areas of Cortez and Durango in the southwest corner.<sup>1</sup>
- 6. Atmos' initial GIP covers the utility's planned projects for the years 2024-2029. Broadly, the GIP discusses Atmos' methodology, criteria, and assumptions to identify applicable planned facilities, extension of existing facilities, or defined programmatic expenses.
- Atmos' initial GIP has an "action period" from January 1, 2023, to December 1, 7. 2026, and an "informational period" through 2029. Planned projects are categorized as system safety and integrity, new business, capacity expansion, mandatory relocation, and defined programmatic expenses. Pursuant to 4 CCR 723-4-4551, reported projects also have a cost estimate that exceeds \$3 million. Thus, Atmos' proposed GIP will affect thousands of customers all across Colorado.
- The General Assembly has recognized that certain Colorado communities have 8. historically been forced to bear a disproportionate burden of adverse human health and environmental effects. The General Assembly further declared that public comment hearings addressing matters pertinent to retail customer programs, at which members of disproportionately-

impacted (DI) communities may offer input, are one means of assuring that DI communities "will have at least proportionate access to the benefits of [retail customer] programs, incentives, and investments." The Commission has followed this approach in its decisions as well. Because a remote public hearing will further the interests of both the General Assembly and the Commission in encouraging input from the public, (and from DI communities in particular), the ALJ will schedule a public comment hearing (as set forth below) in accordance with Commission Decision No. C24-0259.

# A. Necessity of a Public Comment Hearing

- 9. Given the geographic nature of Atmos' service territory, the ALJ is scheduling a remote public comment hearing to best accommodate interested persons appearing from different locations throughout Atmos' Colorado service territory. Two public comment sessions will be held, with the first to include the lunch hour, and the second to run past ordinary business hours (as necessary to accommodate all those who appear). Two sessions provide flexibility for interested persons to appear during their lunch break or after regular business hours, should it be otherwise difficult for them to appear during regular Commission business hours (8:00 a.m. to 5:00 p.m.). This approach also encompasses hearing time during regular business hours, which also accommodates those for whom appearing during business hours is preferred.
- 10. As noted below, a remote public comment hearing is scheduled for Thursday, September 19, 2024, with the first session scheduled from 11:30 a.m. to 1:30 p.m., and the second session from 4:00 p.m. to 6:00 p.m. Both sessions will continue until concluded, meaning that the sessions will continue until all public comments are received, but will end no later than the

designated end-time (1:30 p.m. and 6:00 p.m.). The hearing sessions will not be held open for public comments after all those who have appeared have provided public comment and therefore may conclude before the scheduled end times (1:30 p.m. and 6:00 p.m.). For example, if all those who appear at the 11:30 a.m. session have provided public comment by 1:00 p.m. or earlier, that hearing session will be adjourned. This also means that anyone who chooses to join the public comment hearing sessions after the designated start times assumes the risk that the hearing will be concluded before they join. However, regardless of how early registered participants conclude their comments, the first session will continue at least into the lunch hour and the second session will continue at least past 5:00 p.m.

11. The public comment hearing will be held using the web-hosted video-conferencing service, Zoom. This means that members of the public who wish to participate in the public comment hearing should not appear in person at the Commission's offices but should instead appear remotely via Zoom.

## B. Observing the Public Comment Hearing

12. Consistent with Commission practice, the public comment hearing will be webcast on the Commission's website. Persons wishing to observe, but not provide comments in the hearing may do so by observing the webcast of the hearing and need not register through Zoom. To observe the hearing by webcast, enter this link in the web browser https://puc.colorado.gov/webcasts and select the option for this Proceeding (Proceeding No. 24M-0061G). The assigned hearing room will be identified on the Commission's public calendar for the date and time of the hearing, at the following link: https://puc.colorado.gov/puccalendar.

# C. Participating in the Public Comment Hearing

- 13. Those interested in providing public comment during the hearing must register in advance using a link posted on the calendar of events on the PUC's website at <a href="https://puc.colorado.gov/puccalendar">https://puc.colorado.gov/puccalendar</a>. Registrants will receive an email with a link to provide comment during the Zoom session. If an interested person cannot obtain the link and register, they can contact the PUC for assistance at 303-894-2000.
- 14. Those registered to provide comment during the hearing are strongly encouraged to prepare in advance and familiarize themselves with how to use the Zoom meeting platform. Attachment A to this Decision provides step-by-step technical instructions and requirements to participate by video-conference using a computer. This is intended to ensure that the remote hearing proceeds efficiently. Hence, it is important that registered video-conference participants carefully review and follow all requirements in this Decision and Attachment A.
- 15. For those who wish to provide oral comments during the hearing, video-conference participation is preferred and encouraged because it allows for the hearing to be held in a manner most similar to in-person hearings. Nevertheless, interested persons have the option to participate by telephone.
- 16. The Commission strives to accommodate all members of the public at its hearings by providing services for foreign language users and persons with disabilities upon receipt of a reasonable accommodation request. Registrants requesting an interpreter during the public comment hearing should complete the <a href="Language Access Form">Language Access Form</a> at <a href="https://puc.colorado.gov/how-to-participate">https://puc.colorado.gov/how-to-participate</a> at least one week prior to the event. ## D. Other Methods to Submit Public Comment

- 17. Interested persons wishing to provide public comment need not participate in the public comment hearing to do so. In addition to accepting comments during the public comment hearing, the Commission makes available other means by which interested persons may provide written or oral comments. The Commission prefers written comments over oral comments but gives written and oral comments the same weight.
- 18. Interested persons are encouraged to submit written comments through either: (a) the Commission's Electronic Filing System at <a href="https://www.dora.state.co.us/pls/efi/EFI.homepage">https://www.dora.state.co.us/pls/efi/EFI.homepage</a> in this Proceeding; or (b) the Commission's website at <a href="https://puc.colorado.gov/">https://puc.colorado.gov/</a> by clicking on the "FILE A COMMENT OR COMPLAINT" link. Anyone using the latter option should ensure that their comments include this Proceeding number (Proceeding No. 24M-0061G).
- 19. Oral comments will be accepted from any interested person who leaves a voice mail message at (303) 869-3490 or from registered commenters offering public comment during the scheduled public comment hearing. Those leaving voice mail public comments must include their name, the spelling of their name, and this Proceeding number (Proceeding No. 24M-0061G) in their message. Voice mail messages will be transcribed and placed in the record of this Proceeding.
- 20. The Commission will equally consider public comments, regardless of the format in which they are submitted (verbal or in writing).
- 21. Pursuant to Commission Decision No. C24-0259, initial written comments pertaining to Atmos' Gas Infrastructure Plan are due by July 23, 2024; reply comments are due by August 20, 2024.
