## I. <u>STATEMENT</u>

- 1. On August 28, 2024, Anthony Smith ("Complainant") filed a formal complaint against Towing Operations, LLC, doing business as Wyatt's Towing ("Respondent").
- 2. This matter was referred by minute entry to an Administrative Law Judge ("ALJ") for resolution during the Commission's Weekly Meeting held September 11, 2024.

2024. Based on the parties' agreement as to the date of the evidentiary hearing in this matter, the

evidentiary hearing will be continued to December 6, 2024, as ordered below.
