INTERIM DECISION WAIVING RESPONSE TIME AND GRANTING LONGMONT POWER & COMMUNICATIONS' MOTION FOR EXTENSION

Issued Date: May 12, 2025

I. STATEMENT

- 1. On January 2, 2025, the Colorado Public Utilities Commission ("Commission") opened the above-captioned proceeding as a repository proceeding for the filing of the 2024 annual reports by utilities holding a certificate of public convenience and necessity to provide energy services in the State of Colorado.
- 2. On January 22, 2025, the Commission referred this proceeding by minute entry to an Administrative Law Judge ("ALJ") for the disposition of all pleadings and motions filed in this proceeding.
- 3. On May 1, 2025, Longmont Power & Communications ("Longmont") filed its Motion requesting a 30-day extension of time to file their annual report ("Motion").

II. RELEVANT LAW, ANALYSIS, FINDINGS, AND CONCLUSIONS

4. Because this is an administrative proceeding (and not an adjudicative one), the ALJ will waive the response time to the Motion.¹

5. Longmont requests a 30-day extension because the City's 2024 financial books have not been closed yet and the auditors are currently reviewing the 2024 financial statements.² Along with the Motion, Longmont also filed their report of gross regulated intrastate operating

revenues required by the Colorado Department of Revenue ("Form DR 0525").

6. Pursuant to Rule 3006 of the Commission's Rules Regulating Electric Utilities, 4 Code of Colorado Regulations 723-3, and Rule 4006 of the Commission's Rules Regulating Gas Utilities and Pipeline Operators, 4 Code of Colorado Regulations 723-4, electric utilities and

natural gas utilities shall submit their annual reports on April 30 of each year.

7. In accordance with Rules 3006(a) and 4006(a), an extension of time to file the annual report does not affect the requirement that utilities file the report of gross regulated intrastate operating revenues required on Form DR 0525. The time for filing the required Form

DR 0525 cannot be extended.

8. The ALJ concludes that the Motion provides good cause for a 30-day extension of time to file its Report. The Motion will be granted. Longmont's 2024 Report must be filed by May 30, 2025.

III. **ORDER**

It is Ordered That:

1. Response time to the Motion requesting a 30-day extension of time ("Motion") filed by Longmont Power & Communications ("Longmont") on May 1, 2025, is waived and the Motion is granted.

Longmont's 2024 Annual Report required by Rules 3006 of the Commission's Rules Regulating Electric Utilities, 4 *Code of Colorado Regulations* 723-3 and Rule 4006 of the Commission's Rules Regulating Gas Utilities and Pipeline Operators, 4 *Code of Colorado Regulations* 723-4 must be filed by 5:00 p.m. on May 30, 2025.
- 3. This Decision does not extend or otherwise impact the deadline for Longmont to file its 2024 Form DR 0525.
 - 4. This Decision is effective immediately.
