1. You failed to comply with the surety bond requirements of section 12-61-903(6), C.R.S., section 12-61-907, C.R.S. or any rule of the Director that directly or indirectly addresses surety bond requirements;
2. You failed to comply with the errors and omissions insurance requirement in section 12-61-903.5, C.R.S. or any rule of the Director that directly or indirectly addresses errors and omissions insurance requirements;
3. You failed to maintain current contact information, surety bond information, or errors and omissions insurance information as required by this part 9 or by any rule of the Director that directly or indirectly addresses such requirements;
4. You failed to respond to an investigation or examination;
5. You failed to comply with any of the education or testing requirements set forth in this part 9 or in any rule of the Director that directly or indirectly addresses education or testing requirements; or
6. You failed to register with and provide all required information to the Nationwide Mortgage Licensing System and Registry.

**If you are required to pay an administrative fee, the administrative fee must be received by the Division of Real Estate in the form of a cashier's check or a money order.**
