CONSENT AGREEMENT

COMES NOW the Iowa Board of Medical Examiners (the Board) and Thomas Horiagon, M.D. (Applicant) on 4-9, 2007, and enter into the following Consent Agreement. The Board shall issue Applicant a permanent Iowa medical license under the following terms and conditions, which have been imposed with the Applicant's consent.

1. Applicant is hereby granted Iowa permanent license no. 37188 to practice medicine and surgery in Iowa.
2. Applicant is an internal medicine physician who practices as an intensivist.
3. Applicant practiced at Exempla Lutheran Medical Center, West Ridge, Colorado, from November 2001 to March 2005. Exempla Lutheran Medical Center indicated that the Medical Executive Committee directed Applicant to attend a mandatory meeting with the Medical Executive Committee to discuss complaints regarding Applicant's interpersonal behavior. Applicant failed to attend the mandatory meeting and his privileges were terminated on February 14, 2005.

4. Applicant failed to disclose the information above on his application for permanent Iowa medical licensure.

5. On August 13, 2004, the Colorado Board of Medical Examiners issued Applicant a Letter of Admonition for failing to respond to a complaint issued by the Board in a timely manner.

6. **CITATION AND WARNING:** Applicant is hereby **CITED** for failing to disclose the termination of his privileges on his application for licensure and for failing to appropriately respond to this Board's requests for information from governing committees or boards. Applicant is hereby **WARNED** that such conduct in the future may result in further disciplinary action, including suspension or revocation of his Iowa medical license.

7. **CIVIL PENALTY:** Applicant shall pay a civil penalty in the amount of **\$1,000**. The civil penalty shall be paid within twenty (20) days of the date of this Order by delivery of a check or money order, payable to the Treasurer of Iowa, to the executive director of the Board. The civil penalty shall be deposited into the State General Fund.

8. Applicant shall obey all federal, state and local laws, and all rules governing the practice of medicine in Iowa.

9. This Consent Agreement constitutes the resolution of a contested case proceeding.


10. This Consent Agreement, is voluntarily submitted by Applicant to the Board for consideration.



In the event Applicant violates or fails to comply with any of the terms or conditions of this Consent Agreement, the Board may initiate action to suspend or revoke the Applicant's Iowa medical license or to impose other license discipline as authorized in Iowa Code Chapters 148 and 272 and 653 IAC 25.

12. By entering into this Consent Agreement, Applicant voluntarily waives any rights to a contested case hearing in this matter.

13. This Consent Agreement, is subject to approval of the Board. If the Board fails to approve the Order, it shall be of no force or effect to either party.

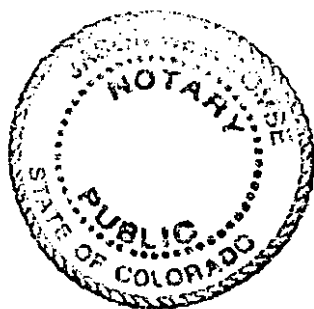
14. The Board's approval of this Consent Agreement shall constitute a **FINAL ORDER** of the Board.
